The meeting was called to order at 9:00 a.m. by President Carrie Hurich who determined there was a quorum.

Minutes of the January 10, 2015 meeting were approved as read.

### President's Report

Carrie welcomed everyone with a reminder that 2015 membership dues are due.

New Neighbors Letter – Pat gave an update with information that Carrie had provided regarding new residents in Burland.

The Treasurer's report was approved as read.

<u>New Business</u> - Jim Glenn suggested we establish a "dream sheet" for things we would like to accomplish in the future such as more members/volunteers, etc. There was discussion and projects suggested were:

- 1 Updates to the park such as play equipment and lights (which are in the planning stage)
- 2 Address the firearms/guns and shooting problems in this residential area with the County Commissioners (present to them documentation for example, with the number of complaints we have received, etc.)
- 3 Trail volunteers to improve and maintain the Mt. Bailey trail (this may possibly be done by somehow increasing community involvement). Jim Glenn mentioned the name of "Nancy" with the Colorado State Forest Service who may be a contact to assist us in getting the trail work and volunteers organized, and Jim had several ideas of what needed to be done to upgrade the trail. Jim volunteered to contact the CSFS for possible assistance.
- 4 Repair/improve the current mailbox stands. There was a lengthy discussion on the improvement of the dilapidated mail boxes that exist throughout the community. In the end, Carrie stated that a committee should be set up to review the needs, process and potential cost for the mail box project, keeping in mind that that committee (or a designated representative) should include input and approval from the Bailey Post Master. Jim Aitkenhead agreed to be the lead on this and to talk with the Post Master.

The meeting was called to order at 9:45 a.m.

Minutes of the January 10, 2015 were approved as read.

The Treasurer's report was approved as read. Roger mentioned that the AT&T lease payment had been resolved; simply a matter of "timing" of the payment involving the old and revised contract.

# President's Report

Covenant Violation - No new complaints.

Carrie reviewed the tree cutting incident, explaining the process and repercussions, the Sheriff's Office involvement, etc. Roger also pointed out that even though someone witnessed the tree being drug down the trail by four people, the HOA has no proof that it was in fact, cut on our property. (It could possibly have been cut on the adjacent property to the north). In the end, it was decided that we will post a sign "No Tree Cutting, Violators will be Prosecuted".

We are meeting with Robert River to finalize the changes and also what we need to do to set up a PayPal account to accommodate online membership payments.

With regard to the new attorney (Fred Wells), Carrie will set up a phone conference with Bill Hudgins and Fred Wells to coordinate and allow for a smooth transition. Roger mentioned that we had asked a number of times for an invoice from Bill; however, to date, we are not in receipt of an invoice.

Park Lease - We just received from Park County (since the Agenda was written) an Addendum to the Park Lease which we have reviewed and will sign as approved. The process is then for this to be signed off by Park County for final. The Addendum extends the lease through December 31, 2017. Mary Ellen explained that this then, allows the Park to be offered as a

"public" park; the County is to pay us \$1.00, and in turn, add the Park as additional insured concerning liability insurance.

Scholarships – This was discussed and there was a Motion; Melissa moved that we again offer two scholarships (\$5,000 each to a PCHS or home schooled graduating senior) reiterating that should there be a tie, a Burland Ranchettes resident would take precedent as the winner. This was seconded by Jim Aitkenhead; a vote was taken and it was unanimously approved.

Jim Glenn asked that when the new attorney is on board, we ask him for any additional vehicles to protect the HOA treasury (in addition to our current investments).

Roger mentioned that two Christmas Light winner checks had not been cashed; and one was just returned in the mail as unforwardable. It was suggested that we simply mail it to the winning address (rather than to the legal owner), and/or take the check to the house. The problem then, is to whom the check would be made payable. Roger will resolve this.

The meeting was adjourned at 10:30 a.m.
