The meeting was called to order at 10:50a.m. and it was determined there was a quorum;

The minutes of the March 09th, 2019 meeting were approved as read.

## Kris Otto Complaint: 17 Kit Lane regarding 3 properties

- 1) Kim Marsh 5196 CR 72 vehicles and trash
- 2) Teresa Eileen Mullins 5130 CR 72 trash and abandoned appliances
- 3) Konrad O Oker Jr. 5222 CR 72 vehicles and trash

Ms. Otto had valid complaints for trash and broken-down vehicles. She has already been in contact with Park County and has spoken with Dominic. After seeing pictures Ms. Otto brought, the board agreed to send our first complaint letter. Debe Whitford will mail out letters. The second complaint letter to follow after thirty days from the first letter if no response.

# Eric Lybarger: Evergreen Investing

- 1) Gave Burland HOA'S current allocation (current portfolio), as captured on 05.10.2010
- 2) The current risk rate is at 35
- 3) Gave our individual performance report as well.
- 4) Our rate of return allows the use of \$1900.00 per month without effecting investments. The last time he met with us it was at \$1700.00.
- 5) Asked the board if we would like to raise the risk score or keep the same.
- 6) Concerns from the board is due to headed to an election year maybe not to raise.
- 7) This will be discussed by the Board.

<u>Treasurer Update</u>: Jack Roberts follow up Property Tax Exemption with Travis Keenan the Burland HOA'S Attorney.

- 1) 28.266-acre tract on Mt. Bailey in question on Exempt report and how to file.
- 2) He believes the association should alter the way in which it has traditionally completed reports.
- 3) We could possibly lose our status of 3014b but may qualify for another type of exemption.

4) Over the past decade the property has evolved to include a cell phone tower that facilitates equipment from a number of cell phone providers.

5) Several providers have constructed small buildings to house their equipment and the

association now generates more than \$6000 in rent every month.

- 6) The Association is now questioning whether it needs to modify this year's report to reflect the changed circumstances.
- 7) Section 4 of the report, he recommends that the Association use the Park County Assessor's estimated value of \$49,480 vs the estimate of \$15,000.
- 8) Section 6 of the report, he would still indicate that the Property's primary use is charitable, and the cell phone tower is ancillary.
- 9) Section 7 of the report he recommends reporting the open-air pavilion the same as we have previously. However, He would also list the buildings that are now present on the property and indicate that they are used to house equipment for the cell phone tower.

10) Section 9 of the report he recommends reporting the same information the Association has

previously reported regarding the park. Add the words wildfire protection.

11) Section 13 of the report he recommends the Association respond that Park County used the property with an unknow number of uses, unknow number of hours, and used the entire property resulting in \$1.00 received by the association. Next list the cell phone providers and indicate each has used the property and list number of hours as continuous. List the amount of rental revenue received from each cell phone provider.

12)Look into Government lease Exemption

Jack Roberts would like everyone to go over 3 page document from Travis and get a better understanding and we will discuss at the next meeting.

Jim Glenn: will get scrapbook photos for picnic.

Jack Roberts: request 4 hardhats with face shield & hearing protection. Also, would like 4 pair of chaps. They can offer added safety for chainsaw mishaps. Amounts are roughly \$80 a piece for hardhats & \$89 each for chaps. Motion to approve from Pat White & Carrie Marsh second with approval of 4 pair each & no need to get approval for amount as long as around the same agreed amounts.

Brandon Shultz offered to donate his services at Pat Escobar's mitigation project. He has his own mitigation business and could possibly be a business that the HOA may offer as a Burland approved mitigation company. That will be determined.

Scholarship for Platte Canyon Senior: Jim Glenn/Pat White: The 2019 Scholarship winner is Joshua Rummelhart. He is a hard worker and recently featured in the Flume. Jim will send the runnerups letters to inform. Joshua will be attending the School of the Mines here in Colorado.

Debe Whitford: When we receive Joshua Rummelhart information will forward to Jack Roberts for the Scholarship Checks.

- Added additional cleanings can be approved by Secretary, as needed If board approves, Debe Whitford and I can present to Ken Barrios.

The Burland HOA is hiring a Park Custodian to maintain Weakland Fawks Park and to monitor the park, that is, be our "eyes and ears" on a regular basis. Job description:

It isn't an hourly thing, it has always been twice a week cleaning usually once during the week and once on the weekend unless there are parties, then as much as needed to accommodate reservations. Typically 30 mins to an hour depending on condition of park each time. So average 1-2 hours per week.

- 1) Bring a bucket of hot soapy water and wash tables/benches each time
- 2) Pick up all trash in park, grills and parking lot
- 3) Check outhouse if it needs more TP and sweep the floor/ pick up trash
- 4) Blow or sweep pavilion concrete pad as well as basketball court
- 5) Blow off all playground equipment and rubber mats
- 6) Make sure all swings and benches are clean from spills and other things
- 7) Report any problems or damage (extra set of eyes)
- 8) Check with Secretary, Debe Whitford, for dates of pavilion reservation to schedule around them

#### Salary:

1-2 hours per week at \$40 per week or \$160 per month. Cleaning supply receipts (bags, TP, soap, etc) turned in monthly and paid by HOA. Turn in receipts and monthly cleanings to Debe Whitford or Jack Roberts for payments.

#### First cleaning in Spring:

Each spring do a spring cleaning of all the mud, rocks and such that made its way into the pavilion and other items so it has a fresh start (as much as you can do for a park in the woods). First cleaning each spring may require an additional cleaning. If a 5th cleaning is needed in May or later, advise secretary, Debe Whitford, 720-397-9000, debeisadolphin@yahoo.com for approval. Cost for that month would then be \$200 plus supplies.
